1 **GENERAL**

1.1 SCOPE

This specification details the ratings, physical and electrical characteristics, and test and inspection data for the component type variants and/or the range of components specified below. It supplements the requirements of, and shall be read in conjunction with, the ESCC Generic Specification listed under Applicable Documents.

1.2 APPLICABLE DOCUMENTS

The following documents form part of this specification and shall be read in conjunction with it:

(a) ESCC Generic Specification No. 3001.

1.3 TERMS, DEFINITIONS, ABBREVIATIONS, SYMBOLS AND UNITS

For the purpose of this specification, the terms, definitions, abbreviations, symbols and units specified in ESCC Basic Specification No. 21300 shall apply.

1.4 THE ESCC COMPONENT NUMBER AND COMPONENT TYPE VARIANTS





2 **REQUIREMENTS**

2.1 GENERAL

The complete requirements for procurement of the components specified herein are as stated in this specification and the ESCC Generic Specification. Permitted deviations from the Generic Specification, applicable to this specification only, are listed below.

Permitted deviations from the Generic Specification and this Detail Specification, formally agreed with specific Manufacturers on the basis that the alternative requirements are equivalent to the ESCC requirement and do not affect the component's reliability, are listed in the appendices attached to this specification.

2.1.1 <u>Deviations from the Generic Specification</u>

2.1.1.1 Deviations from Qualification and Periodic Tests - Chart F4

- (a) Resistance to Soldering Heat and Solderability:
 - For Variants 01 to 04: Immersion depth shall be between 2mm and 2.5mm from the body.
 - For Variants 05 to 16: Only the part of the leads designed to be soldered shall be tested.
- (b) Vibration: Prior to Vibration, the samples shall be mounted and glued on to a suitable substrate in order to avoid any stress. The samples shall be maintained on the substrate for all subsequent tests in the subgroup test sequence.

2.2 MARKING

The marking shall be in accordance with the requirements of ESCC Basic Specification No. 21700 and as follows.

The information to be marked on the component or the primary package shall be:

- (a) The ESCC qualified components symbol (for ESCC qualified components only).
- (b) The ESCC Component Number (see Para. 1.4.1).
- (c) Traceability information.

2.3 ROBUSTNESS OF TERMINATIONS

The leads of these devices are classified as rigid.

The test conditions for Robustness of Terminations shall be as specified in the ESCC Generic Specification and as follows:

For Variants 01 to 04:

- Applicable test: Ua1 (tensile) only.
- Leads tested: a minimum of one randomly selected lead on each side of the component.
- Applied force: 5N

For Variants 05 to 16:

- Applicable test: Ue3 (shear) only.
- Pushing force: 10N for 10s



2.4 <u>ELECTRICAL MEASUREMENTS AT ROOM, HIGH AND LOW TEMPERATURES</u> Electrical measurements shall be performed at room, high and low temperatures.

2.4.1 Room Temperature Electrical Measurements

The measurements shall be performed at $T_{amb} = +22 \pm 3^{\circ}C$.
