Page 7, Table 1(a): add new variants 57 to 72 for shell sizes 69 & 100; see attached for details.

Pages 8 to 11, Fig 2(a) to 2(d): Add dimensions for shell sizes 69 & 100 to tables.

In header row, dimensions A B D E F are now listed as Typ. (i.e. typical values)

In header row, dimension C is now identified as BSC (i.e. Basic Space Centres)

Page 13, Para 4.4.1: Include new variants 57 to 72 in the lists by amending sentences; see attached for details.

Nickel thickness for gold plated variants is corrected to be 25.4um (was 2.54um)
