Justification:

Approved DCR 567 (Approved at PSWG 43 2010/03/10) changed the requirement for ESCC 4009 Chart F4 Endurance Subgroup from 24 months to 12 months. (The period had been 24 months since DCR 229 was approved and implemented into Issue 3 in September 2006.)

In approving DCR 567 PSWG stated that the 24 months basis should be maintained for IRCA, RICA Division.

RICA, as an ESCC qualified manufacturer (Certificate No. 184 April 1992 to the present), has the necessary accumulated endurance subgroup test data to support the continuation of the subgroup testing on a 24 month basis. The summary of recent test data is as follows:
