## 1 **GENERAL**

#### 1.1 SCOPE

This specification details the ratings, physical and electrical characteristics, test and inspection data for Accessories for 3401/073 Solar Array Connectors. The specification shall be read in conjunction with:

- ESCC Generic Specification No. 3401, Connectors, Electrical, Non-Filtered, Circular and Rectangular.
- ESCC Detail Specification No. 3401/073, Connectors, Electrical, Solar Array with Removable Crimp Contacts based on type D-PASO.

the requirements of which are supplemented herein.

#### 1.2 <u>TYPE VARIANTS</u>

The accessories specified herein, which are also covered by this specification are scheduled in Table 1(a).


## **FIGURE 1 - PARAMETER DERATING INFORMATION**





#### **CONSOLIDATED NOTES FOR FIGURE 2**

- All variants shall be able to guide and hold, without damaging, wires for each contact as follows:
  - (a) One wire of maximum diameter of 1.4mm (AWG 22 or 24).
  - (b) Two wires of maximum diameter of 1mm (AWG 24)
  - (c) One flat wire of 0.227 thickness and 3.5mm width.
- 2. Variants 01 and 02 are supplied with the following screws:
  - 1 x captive centre locking screw M2 x 12
  - 4 x clamp screw M2 x 4.5
- 3. Variant 03 is supplied with the following screws:
  - 1 x captive centre locking screw M2 x19
  - 2 x captive outer locking screw M2 x 40
  - 4 x clamp screw M2 x 4.5
- 4. All variants are supplied with flat silicone gaskets to hold wire types per Note 1.
- 5. All screws shall have Hexalobular Internal Driving Heads.

#### 4 REQUIREMENTS

#### 4.1 GENERAL

The complete requirements for procurement of the components specified herein are stated in this specification and ESCC Generic Specification No. 3401. Deviations from the Generic Specification, applicable to this specification only, are detailed in Para. 4.2.

Deviations from the Generic Specification and this Detail Specification, formally agreed with specific Manufacturers on the basis that the alternative requirements are equivalent to the ESCC requirements and do not affect the components' reliability, are listed in the appendices attached to this specification.

## 4.3 MECHANICAL REQUIREMENTS

#### 4.3.1 Dimension Check

The dimensions of the accessories specified herein shall be verified in accordance with the requirements set out in Para. 9.6 of ESCC Generic Specification No. 3401 and they shall conform to those shown in Figure 2 of this specification.

#### 4.3.2 Weight

The maximum weight of the accessories specified herein shall be as shown in Table 1(a) of this specification.

## 4.3.3 <u>Maximum Torque Value</u>

The maximum torque value to be used for tightening of the screws of the accessories specified herein shall be as specified in Table 1(b) of this specification.

#### 4.4 MATERIALS AND FINISHES

The materials and finishes shall be as specified herein. Where a definite material is not specified, a material which will enable the components specified herein to meet the performance requirements of this specification shall be used. Acceptance or approval of any constituent material does not guarantee acceptance of the finished product.

#### 4.4.1 Accessory Bodies

Accessory bodies shall be made of Aluminium Alloy. The plating shall be 1.27µm minimum of gold over electroless nickel.

#### 4.4.2 Holding Fixture Gaskets

The gaskets for all variants shall be made of silicone elastomer.

#### 4.4.3 <u>Locking Jackscrews</u>

All jackscrews supplied with all Variants shall be Brass with  $1.27\mu m$  minimum of gold plating over copper underplating of 0.4 to 0.6  $\mu m$  thickness.

#### 4.4.4 Magnetism Level

As specified in ESCC Detail Specification No. 3401/073.

## 4.5 MARKING

#### 4.5.1 General

The marking of components delivered to this specification shall be in accordance with the requirements of ESCC Basic Specification No. 21700 and the following paragraphs.

The information to be marked and the order of precedence, shall be as follows:

- (a) The ESCC Component Number.
- (b) Traceability Information.
