Subject: Verification to ECSS-Q-ST-70-38C.

Status of Surface Mount technology (SMT) as of January 2013

Please find hereafter the current update of the assembly approval status as per ECSS-Q-ST-70-38C of the Companies which have submitted their application to ESA. The verification of a Company is not a general approval, but relates uniquely to the materials (i.e. Type of PCB laminate, type of solder, type of conformal coating, etc.) to the precise types of components/packages and to the design of the foot print that were subjected to the verification programme performed in accordance to the ECSS-Q-ST-70-38C. Each Summary Table has a unique QM or TEC/QT reference number which should be identified in the relevant ESA Project's Declared Process List.

It is under the responsibility of the Company to ensure that all devices and configurations being assembled on the Printed Circuit Boards are in the ESA Approved Summary Tables and that no changes have been made.

It is usual to have a running verification programme with a Company due to change in the processes, materials, vibration levels or presence of new devices.

The status of the Companies varies frequently and therefore an updated letter will be issued every 3 months and can be found on the esmat website (http://esmat.esa.int/Databases/SMTLetter.pdf).

Thirty five Companies have currently verified lines, forty are presently involved in verification or delta verification programme, and some have expressed an interest to become verified.
