The cause of the anomaly (metal peeling) is likely due to oxide surface pollution prior to metallization. This affected a batch produced in 2012 on the old plant. Investigations (Failure analysis) on are still on-going to better understand the root cause of the defect. However, considering the corrective actions implemented by Exens we propose not to delay the renewal of qualification of the new production site.
