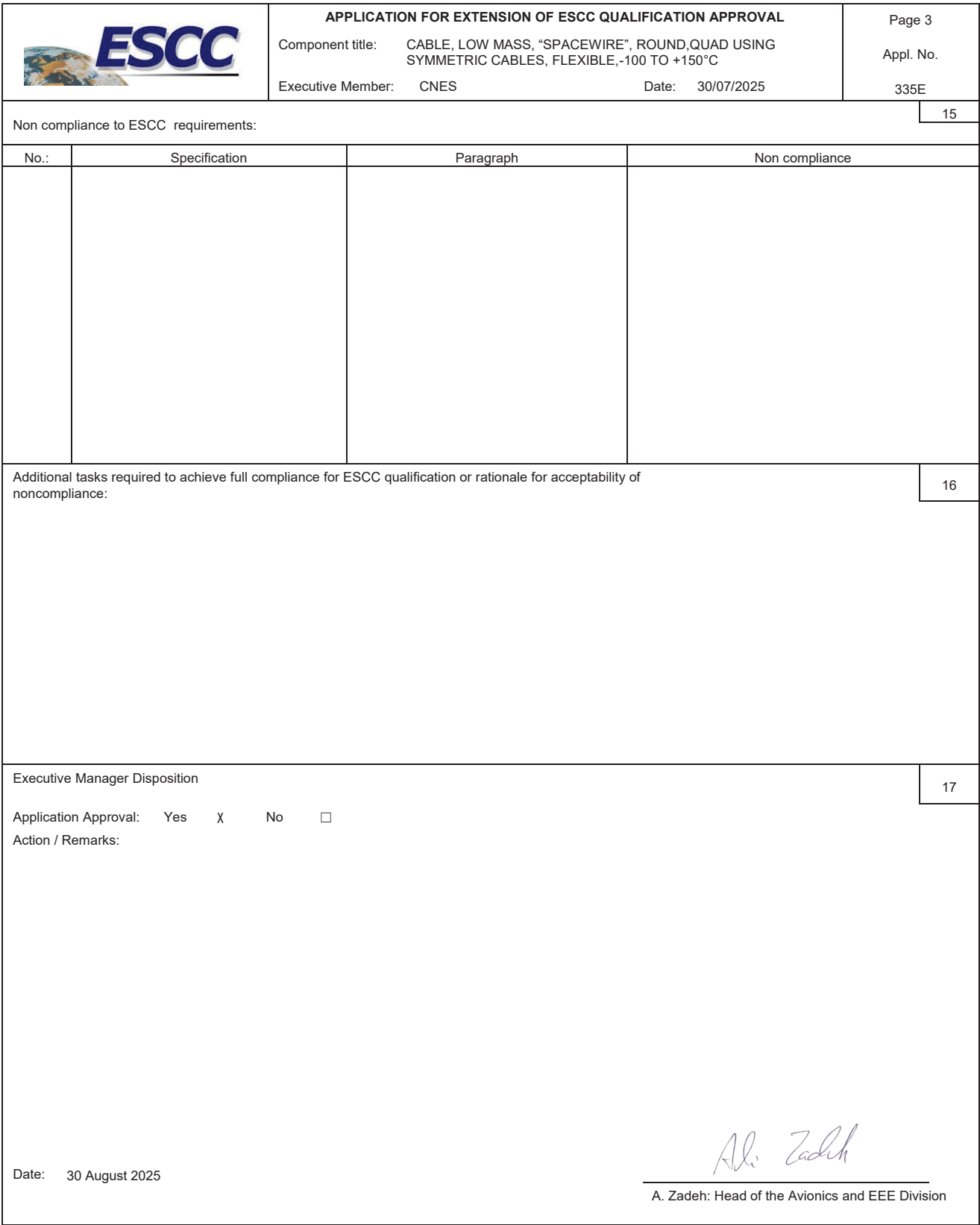

ENTRIES
